1.0 Summary

An announced inspection of Loughry Dental Practice took place on 6 March 2017 from 10:00 to 10:30.

The application for variation of registration related to a proposed increase in the number of dental chairs, from two to three.

The variation to registration complied with estates environmental requirements and is deemed as approved, subject to care inspector approval.
