# Announced Enforcement Compliance Inspection of Rose Martha Court

## 1. Summary of Inspection

An announced enforcement compliance inspection took place on 10 June 2015 from 10:00 to 12:45 hours.

The purpose of the inspection was to assess the level of compliance achieved by the home regarding the three Failure to Comply Notices issued on 27 March 2015.

The areas for improvement and compliance with regulation were in relation to management arrangements (FTC/NH/11107/2014-15/01(E)), staffing arrangements (FTC/NH/11107/2014-15/02(E)) and record keeping, reporting and care planning (FTC/NH/11107/2014-15/03(E)).

The date for compliance with the notices was 10 June 2015.

# 1.1 Actions/Enforcement Taken Following the Last Care Inspection

Following an unannounced care inspection on 18 March 2015, three Failure to Comply Notices were issued with regards to management arrangements, staffing arrangements and record keeping, reporting and care planning. The notices were extended up to the legislative timeframe of 90 days following an enforcement compliance inspection on 11 May 2015 which identified that five of the required actions within the three notices were not addressed in full.

## 1.2 Actions/Enforcement Resulting From this Inspection

As indicated above, evidence was available to validate full compliance with the three Failure to Comply Notices issued on 27 March 2015.

No further enforcement was taken as a result of this inspection.

## 3. Inspection Focus

The inspection sought to assess the level of compliance with the five required actions indicated within the three Failure to Comply Notices issued on 27 March 2015 and which were not fully addressed at a previous enforcement compliance inspection on 11 May 2015.

#### 4. Methods/Process

Specific methods/processes used in this inspection include the following:

- discussion with the manager and regional manager
- discussion with patients and staff
- review of a sample of care records including care charts
- review of duty rotas from week commencing 18 May 2015 to date
- observation of care practices
- evaluation and feedback.

## 5. The Inspection

## 5.1 FTC Ref: FTC/NH/11107/2014-15/01(E)

Notice of Failure to Comply with the Nursing Homes Regulations (Northern Ireland) 2005

Regulation 20 (1) (a)

The registered person shall, having regard to the size of the nursing home, the statement of purpose and the number and needs of patients –

 (a) ensure that at all times suitably qualified, competent and experienced persons are working at the nursing home in such number as are appropriate for the health and welfare of patients; Following the enforcement compliance inspection on 11 May 2015, two required actions within this Failure to Comply Notice still required to be fully addressed as follows:

• staff must be able to identify the line management arrangements in place in the home

Discussion with staff confirmed that they were aware of who their line manager was and the identity and role of the registered nurse, designated as being in charge of the home, in the absence of the registered manager.

 daily care must be delivered in a timely manner to ensure that individual patient's needs are met

Review of care records, discussion with patients and staff and observations during this inspection evidenced that care was delivered in a timely manner. Records clearly recorded the delivery of care in relation to wound care including appropriate referrals to specialist healthcare professionals. Nurse call bells were answered promptly. Patients spoken with confirmed that care delivery had improved.

#### **Outcome**

Evidence was provided to validate full compliance with the requirements of the Failure to Comply Notice.

## 5.2 FTC Ref: FTC/NH/11107/2014-15/02(E)

Notice of failure to comply with the Nursing Homes Regulations (Northern Ireland) 2005

## Regulation 20 (3)

The registered person shall ensure that at all times a nurse is working at the nursing home and that the registered manager carries out a competency and capability assessment with any nurse who is given the responsibility of being in charge of the home for any period in his absence.

Following the enforcement compliance inspection on 11 May 2015, two required actions within this Failure to Comply Notice still required to be fully addressed as follows:

• the nurse in charge of the home must be clearly identified on the duty rota.

Review of duty rotas from week commencing 18 May 2015 to date, evidenced that the nurse in charge of the home was identified on the duty rota.

• Staff on duty must be able to identify the nurse in charge of the home in the absence of the manager.

Staff consulted were able to confirm the nurse in charge of the home in the absence of the manager.

#### **Outcome**

Evidence was provided to validate full compliance with the requirements of the failure to comply notice.

## 5.3 FTC Ref: FTC/NH/11107/2014-15/03(E)

Notice of failure to comply with the Nursing Homes Regulations (Northern Ireland) 2005

Regulation 19 (1) (a) Schedule 3 (3) (k)

- 19 (1) The registered person shall -
- (a) maintain in respect of each patient a record which includes the information, documents and other records in Schedule 3 relating to the patient;

Schedule 3 -

- (3) A record of the following matters in respect of each patient –
- (k) a contemporaneous note of all nursing provided to the patient, including a record of his condition and any treatment or surgical intervention;

Following the enforcement compliance inspection on 11 May 2015, one required action within this Failure to Comply Notice still required to be fully addressed as follows:

 Any issues identified with the condition of the patient's skin must be recorded on the repositioning chart, reported to the registered nurse and addressed in a plan of care for the patient.

A review of sample of care records evidenced that care plans were in place to manage the risk of developing a pressure ulcer through repositioning. Care plans specified the frequency of repositioning.

A review of a sample of repositioning charts evidenced that nursing and care staff consistently and accurately completed charts in accordance with the patients' care plans. Records included the status of the patient's skin at the time of each repositioning.

#### Outcome

Evidence was provided to validate full compliance with the requirements of the Failure to Comply Notice.
