- decontamination of reusable dental instruments
- radiology and radiation safety
- management of complaints
- regulation 26 visits, if applicable
- review of areas for improvement from the last inspection

D J Maguire and Associates Ltd is the registered provider for ten dental practices registered with RQIA. Mr Maguire is the responsible person for D J Maguire and Associates Ltd.

4.0 Inspection summary

An announced follow-up care inspection took place on 20 August 2019 from 10:00 to 10:30. Arrangements in respect of conscious sedation were not inspected by RQIA during the initial announced care inspection on 30 April 2019. A further inspection was conducted to address this outstanding key patient safety area.

This inspection was underpinned by The Health and Personal Social Services (Quality, Improvement and Regulation) (Northern Ireland) Order 2003, The Independent Health Care Regulations (Northern Ireland) 2005, The Regulation and Improvement Authority (Independent Health Care) (Fees and Frequency of Inspections) (Amendment) Regulations (Northern Ireland) 2011 and the Department of Health (DoH) Minimum Standards for Dental Care and Treatment (2011).

During the inspection the inspector met with Mr Derek Maguire, responsible individual, Mr Leonard Maguire, clinical director for D J Maguire and Associates Ltd, and a manager for D J Maguire and Associates Ltd. A tour of some areas of the premises was also undertaken.

5.0 The inspection

5.1 Review of areas for improvement from the most recent inspection dated 30 April 2019

The most recent inspection of the establishment was an announced care inspection. No areas for improvement were made during this inspection.

5.2 Review of areas for improvement from the last care inspection dated 30 April 2019

There were no areas for improvement made as a result of the last care inspection.

5.3 Inspection findings

5.4 Conscious sedation

Conscious sedation

Conscious sedation helps reduce anxiety, discomfort, and pain during certain procedures. This is accomplished with medications and (sometimes) local anaesthesia to induce relaxation.

Mr Maguire confirmed that conscious sedation is provided in the form of inhalation sedation, known as relative analgesia (RA). The practice does not offer oral sedation or intravenous sedation (IV) to patients.

A policy and procedure in relation to the management of conscious sedation is in place. Review of the environment and equipment evidenced that conscious sedation is being managed in keeping with Conscious Sedation in The Provision of Dental Care (2003).

Review of care records evidenced that the justification for using sedation, consent for treatment; pre, peri and post clinical observations were recorded. Information was available for patients in respect of the treatment provided and aftercare arrangements.

Mr Maguire confirmed that all members of the dental team providing treatment under conscious sedation have received appropriate supervised theoretical, practical and clinical training before undertaking independent practice in keeping with best practice. Mr Maguire confirmed that recent amendments had been made to include this specific component of training within the dental nurse's induction programme. Mr Maguire confirmed that conscious sedation refresher training in accordance with best practice is planned for October 2019 and all dental staff involved in the provision of conscious sedation will be requested to attend.

A review of records and discussion with Mr Maguire confirmed that the RA equipment has been serviced in keeping with manufacturer's instructions. Review of the sedation policy and discussion with Mr Maguire confirmed that a nitrous oxide risk assessment had been completed to identify the risks and control measures required in required in keeping with the Northern Ireland Adverse Incident Centre (NIAIC) alert NIA-2017-001 issued on 6 September 2017.

Areas of good practice

A review of arrangements in respect of conscious sedation evidenced that all dental practitioners are providing conscious sedation treatments in keeping with best practice guidance.

Areas for improvement

No areas for improvement were identified during the inspection.
