4.0 Inspection summary

An unannounced inspection took place on 6 July 2018 from 10:45 to 13:30

This inspection was underpinned by:

- The Nursing Homes Regulations (Northern Ireland) 2005
- Department of Health, Social Services and Public Safety (DHSSPS) Care Standards for Nursing Homes, April 2015

Examples of summaries:

The purpose of the inspection was to assess issues relating to variation application ref VA010965.

The nursing home residential accommodation was to increase from 34 beds to 37 beds, and a separate residential home was to be established within the building, decreasing the former residential care accommodation from 31 beds to 28 beds.

This transfer of registered accommodation will include a transfer of nursing patients to the ground floor level and a transfer of residential category service users to the first floor.

This will permit the separation of residential care from nursing care categories, and the creation of a separate residential care home within the existing building.

The following areas were examined during the inspection:

- Fire risk assessment and associated control measures records
- Legionella risk assessment and associated control measure records
- Building engineering services maintenance records

A representative sample of accommodation was reviewed during the inspection process.

5.0 Inspection outcome

Health & Safety:

- 2. Medical equipment/devices maintenance sterilisation & calibration certificates were not available for examination at the time of inspection. Jim Fowler, Runwood Homes Ltd, Health & Safety Manager submitted an e-mail on 8 July 2018 confirming that a maintenance service regime had been arranged for this issue.

There were no other items identified as requiring improvement/clarification during the inspection.
