I would confirm the following matter with regard to above:

An inspection of Carnmoyne Residential Care Home in Ahoghill was carried out by RQIA on 11 December 2014. Mrs. Emma Logan, Registered Responsible Person and Registered Manager was present during this inspection. Ms. Gemma Mulholland, RQIA Estates and the plumber for the home were also present. This inspection focused specifically on water safety with the emphasis on the controls in relation to legionella bacteria and scalding.

The previous Estates inspection to this home was carried out on 20 March 2014. One of the issues included in the Quality Improvement Plan for the Estates inspection that was carried out on 20 March 2014 related to water safety (legionella bacteria and scalding risk). This issue was the specific focus for the current Estates inspection. As the current Estates inspection focused specifically on water safety, the other issues included in the Quality Improvement Plan for the Estates inspection that was carried out on 20 March 2014 were not reviewed. These issues were followed up separately by RQIA and have been confirmed as addressed.

RQIA considers that action is required by the Registered Persons in relation to item 1 noted below in order to ensure compliance with the above legislation and standards:

Standard 28 - Safe and healthy working practices

Previous Issue

1. A current risk assessment for legionella bacteria in the water systems was not presented for review during this Estates inspection. The hot water temperatures throughout the premises were still being controlled by central mixing valves located at the hot water cylinders. This arrangement would not be in line with the current standards for either legionella bacteria or scalding controls. A comprehensive risk assessment in relation to legionella bacteria in the water systems should be carried out by a person with expertise in this area. This should include a basic schematic drawing for the water systems in the premises.

In addition, a risk assessment should be carried out in relation to the scalding hazard. The outcome of the risk assessment in relation to the scalding hazard should inform a programme of work to install temperature controls at the water outlets accessible to the residents. The specification for the existing temperature controls in place for the showers should be checked to ensure that these are **DO8 Type 3 fail-safe thermostatic mixers**. It this is not the case, the existing controls should be changed to DO8 Type 3 fail-safe thermostatic mixers.

The installation of the cold water storage tanks in the roof space should be checked as part of the legionella risk assessment. In particular the installation of the vent pipework for the hot water cylinders should be reviewed as this appeared to feed into the cold water tanks. This would not be in line with current good practice.
