# Unannounced Medicines Management Inspection of Kilbroney House

# 1. Summary of Inspection

An unannounced medicines management inspection took place on 9 November 2015 from 10.00 to 12.50.

Overall on the day of the inspection the management of medicines was found to be safe, effective and compassionate. The outcome of the inspection found no areas of concern. A Quality Improvement Plan (QIP) was not included in this report.

This inspection was underpinned by the Department of Health, Social Services and Public Safety (DHSSPS) Care Standards for Nursing Homes, April 2015.

# 1.1 Actions/Enforcement Taken Following the Last Medicines Management Inspection

An urgent action relating to one action was issued at the end of the last inspection. It detailed an issue which required immediate attention to ensure that the prescribing status of three medicines was clarified with the prescribers. This was addressed following the inspection.

Following the last inspection, on 21 July 2015, areas of concern were identified. It was found that improvements in the management of medicines were necessary in order for care to be safe, effective and compassionate. Following discussion with senior management in RQIA, a decision was made to invite the registered person to attend a serious concerns meeting to discuss the areas which had been identified for improvement. This meeting was held on 30 July 2015. At the meeting, the registered person provided a full account of the actions that had already been taken and arrangements which would be implemented to ensure that issues would be addressed to ensure compliance with legislative requirements and the minimum standards. RQIA considered the matter and confirmed that the registered person would be given a period of time to address the matters and that a monitoring inspection would be arranged.

Enforcement action did not result from the findings of this inspection.

# 3. Inspection Focus

The medicines management inspection on 21 July 2015 had shown that robust arrangements were not in place for the management of medicines and improvements were necessary in order for care to be safe, effective and compassionate. This inspection sought to assess what progress had been made in addressing the requirements and recommendations made during the last medicines management inspection and to determine the level of compliance with legislative requirements and the DHSSPS Care Standards for Nursing Homes and to determine if the safety of patients with respect to the administration of medicines could be assured.

#### 4. Methods/Process

Specific methods/processes used in this inspection include the following:

Prior to the inspection, we reviewed the management of incidents reported to RQIA since the previous medicines management inspection.

During the inspection we met with the registered manager and registered nurse on duty.

# 5. The Inspection

# 5.1 Review of Requirements and Recommendations from the Previous Inspection

The previous inspection of the home was an unannounced medicines management inspection dated 21 July 2015. The completed QIP was approved by the pharmacist inspector.

# 5.3 The Management of Medicines

# Is Care Safe? (Quality of Life)

Significant improvements in all areas of the management of medicines were observed since the last medicines management inspection. These improvements must be sustained.

Safe systems were in place for the ordering, receiving and administration of medicines. One registered nurse had been allocated additional hours to coordinate the ordering and receipt of medicines. The audits performed on a random selection of medicines indicated that the vast majority of medicines had been administered in accordance with the prescribed dosage directions. The discrepancies noted were drawn to the attention of the registered manager who agreed to monitor the administrations of the medicines in order to ensure compliance with the dosage instructions.

The medicine records had been maintained in a satisfactory manner. Records of the ordering, receipt, prescribing, administration and disposal of medicines were maintained. Where transcribing of medicine details on the personal medication record had occurred, this process had involved two registered nurses to ensure the accuracy of the record; this is good practice.

# Is Care Effective? (Quality of Management)

There was evidence that medicines were being managed by staff who had been trained and deemed competent to do so. Competency assessments had been completed on the registered nurses since the previous medicines management inspection.

There were robust arrangements in place to audit practices for the management of medicines. The registered manager had delegated the responsibility to carry out medication audits to one of the registered nurses. A review of the audit records indicated that largely satisfactory outcomes had been achieved. The audit process was facilitated by the good practice of recording the dates and times of opening on the medicine containers.

# Is Care Compassionate? (Quality of Care)

The records pertaining to a small number of patients who were prescribed medicines for the management of distressed reactions were reviewed at the inspection. The care plans detailed the circumstances under which the medication was to be administered. The parameters for administration were recorded on the personal medication records. The medicines administration records indicated that the medicines were being administered in accordance with the prescribers' instructions; for all patients these medicines had been administered infrequently. A record of each administration had been maintained and the reason for and outcome of administration were recorded.

The records pertaining to a small number of patients who were prescribed medicines for the management of pain were reviewed. The registered nurse confirmed that patients had pain reviewed as part of their admission assessment. Medicines which were prescribed to treat or prevent pain were recorded on the personal medication records. Examination of the administration of these medicines indicated that they had been administered as prescribed. This included analgesics which were prescribed for administration on either a regular or "when

required" basis. There were care plans in place which detailed the management of the patients' pain. Regular evaluation of pain control was performed and recorded.
