Christine Collins MBE was appointed as Interim Chair of RQIA in June 2020. She held the post simultaneously with that of Chair of the Patient Client Council until October 2022, when she was appointed as RQIA Chair. Her term of office will expire at the end of September 2026.

Formerly a senior civil servant, after retirement Christine worked as a short term expert on EU funded anti corruption programmes in Romania (2006-2009); served as a Board Member, then as Deputy Chair of the Huntington's Disease Association for Northern Ireland (2008-2014) taking the association from unincorporated status to a registered Charity; led the formation, and served as Chair (2011-2016) of the Northern Ireland Rare Disease Partnership, a charity bringing together all those living and working with rare disease in NI; and served as a Commissioner on the Northern Ireland Human Rights Commission (2011-2017). She was a lay Member of the UK wide Rare Disease Advisory Group (2013-2018), and was actively involved in the development and implementation of the UK wide Rare Disease Strategy and the Northern Ireland Action Plan (2011-2017). Currently she is the Queens University Belfast lead for the patient public involvement and engagement strand of the LifeArc funded Rare Disease Trials Acceleration programme; and Interim Co-Chair of the Northern Ireland Rare Disease Partnership, promoting the development of a Northern Ireland Centre of Excellence for Rare Disease.
