| <p>Donard Murray is a supported living type domiciliary care agency that provides care and support for up to eleven adults living with Autistic Spectrum Conditions and/or a learning disability. The care provided by Autism Initiatives is commissioned by a number of Health and Social Care (HSC) Trusts.</p> <p>Care and support is provided under the direction of a manager, a team leader, senior support workers and a team of support workers based at the agency's registered office which is located in the same building as the home of the supported people. Staff currently provide support to nine people supported.</p> |                                               |

## 2.0 Inspection summary

An unannounced inspection took place on 11 November 2024, between 9.45 a.m. and 3.45 p.m. by a care inspector.

The inspection was undertaken to evidence how the domiciliary care agency is performing in relation to the regulations and standards; and to determine if the domiciliary care agency is delivering safe, effective and compassionate care and if the service is well led.

The inspection established that safe, effective and compassionate care was delivered to service users receiving support from the agency and that the service was well led. Details and examples of the inspection findings can be found in the main body of the report.

It was evident that staff promoted the dignity and well-being of service users and that staff were knowledgeable and well trained to deliver safe and effective care.

Service users said that they enjoyed living in the supported living service and that they felt that staff supported them well. Refer to Section 3.2 for more details.

As a result of this inspection one area for improvement was identified. Full details can be found in the main body of this report and in the Quality Improvement Plan (QIP) in Section 4.

We wish to thank the person in charge, staff and service users for their support and cooperation during the inspection.

### **3.0 The inspection**

#### **3.1 How we Inspect**

RQIA's inspections form part of our ongoing assessment of the quality of services. Our reports reflect how the domiciliary care agency was performing against the regulations and standards, at the time of our inspection, highlighting both good practice and any areas for improvement. It is the responsibility of the provider to ensure compliance with legislation, standards and best practice, and to address any deficits identified during our inspections.

To prepare for this inspection we reviewed information held by RQIA about this agency. This included registration information, and any other written or verbal information received from service users, relatives, staff or the commissioning trust.

The inspection examined the agency's governance and management arrangements, reviewing areas such as staff recruitment, professional registrations, staff induction and training and adult safeguarding. The reporting and recording of accidents and incidents, complaints, whistleblowing, Deprivation of Liberty Safeguards (DoLS), Service user involvement, Restrictive practices and Dysphagia management were also reviewed.

Throughout the inspection process inspectors will seek the views of those living, working and visiting the home; and review/examine a sample of records to evidence how the home is performing in relation to the regulations and standards.

#### **3.2 What people told us about the service and their quality of life**

Throughout the inspection the RQIA inspector will seek to speak with service users, and where appropriate their relatives and staff, to obtain their opinions on the quality of the care and support, their experiences of living or working in this agency.

Through actively listening to a broad range of service users, RQIA aims to ensure that the lived experience is reflected in our inspection reports and quality improvement plans.

We spoke to a number of service users and staff to seek their views of living and working within Donard Murray.

Service users spoke positively about their experience of the support provided by the agency; they said they enjoyed living in the supported living service and that the staff supported them well. Observations of staff interacting with service users was noted to be person centred and caring.

Staff spoke very positively in regard to the care delivery in the agency. One told us that they loved working in the service and that service users were safe and well looked after.

Staff indicated that they were well supported by the manager and that the induction and training provided was good. Staff described the support they provided to service users to help them participate in activities of their choice.

The information provided indicated that those we spoke with did not have any concerns in relation to the care and support provided within the supported living service.

No questionnaires were returned.

There were no responses to the electronic survey.

### **3.3 What has this service done to meet any areas for improvement identified at or since the last inspection?**

The last care inspection of the agency was undertaken on 28 April 2023 by a care inspector. No areas for improvement were identified.

## **3.4 Inspection findings**

### **3.4.1 Staffing Arrangements**

Safe staffing begins at the point of recruitment and continues through to staff induction, regular staff training and ensuring that the number and skill of staff on duty each day meets the assessed needs of service users.

A review of the agency's staff recruitment records confirmed that pre-employment checks, including criminal record checks (AccessNI), were completed and verified before staff members commenced employment and had direct engagement with service users.

There was evidence that all newly appointed staff had completed a structured orientation and induction which also included shadowing of a more experienced staff member. Written records were retained by the agency of the person's capability and competency in relation to their job role. One staff member said that their induction was good and had helped them learn the job role.

There were no volunteers providing support within the domiciliary care agency.

The agency has maintained a record for each member of staff of all training, including induction and professional development activities undertaken; records are retained electronically. The review of training records evidence that staff had completed appropriate training to meet the needs of the service users.

There was evidence of effective systems in place to manage staffing. Sufficient staff were on duty to support the service users. Staff said there was good teamwork and that they felt well supported in their role by the manager. Staff said that there were enough staff to meet the needs of the service users. It was observed that staff responded to requests for assistance promptly in a caring and compassionate manner.

It was evident that staff had a good understanding of the needs, likes and dislikes of individual service users. The agency recently completed a recruitment process to appoint new team leaders.

Staff meetings were facilitated on a regular basis and a record of the matters discussed was retained.

Observation of the delivery of care evidenced that service users' needs were met in a safe, effective and compassionate manner.

### **3.4.2 Care Delivery**

Staff interactions with service users were observed to be polite, friendly, warm and supportive and the atmosphere was calm, relaxed, pleasant and friendly. Staff were knowledgeable of individual service users' needs, their daily routine, wishes and preferences.

Staff were also observed offering service users support to engage in the activities they choose to participate in. Service users described how staff supported them to access the local community and participate in activities they enjoyed. Staff were also observed offering service user choice in how and where they spent their day.

The agency does not currently facilitate service user engagement meetings due to the needs and wishes of the service users. However, it was identified that staff meet with service users individually to discuss the provisions of their care.

Care reviews had been undertaken in keeping with the agency's policies and procedures. There was also evidence of regular contact with service users and as appropriate their representatives.

### **3.4.3 Management of Care Records**

Service users' needs were assessed and risk assessments completed prior to receiving care and support from the domiciliary care agency. Following this initial assessment, they were assessed again at regular intervals. Care plans were developed to direct staff on how to meet the service users' needs in a safe and effective manner.

Service users, where possible, were encouraged and supported to be involved in planning their own care and the details of care plans were shared with their relatives, as appropriate.

Care and support plans were person centred and are kept under regular review. There was evidence that staff record regularly the details of the care and support provided or any changes to the service users' needs. and regularly reviewed and updated to ensure they continued to meet the service users' needs. Service users and /or their relatives participate, where appropriate, in the review of the care provided on an annual basis, or when changes occur.

### 3.4.4 Quality of Management Systems

There has been a change in the management of the domiciliary care agency since the last inspection. Miss Catherine Murphy is currently an acting manager arrangement and an application to be registered has been submitted. Staff commented positively about the management arrangements and described the manager and senior staff as supportive, approachable and always available to provide guidance.

There were monthly monitoring arrangements in place in compliance with Regulation 23 of The Domiciliary Care Agencies Regulations (Northern Ireland) 2007. A review of the reports of the agency's monthly quality monitoring established that there was engagement with service users, service users' relatives, staff and Trust representatives. The reports included details of a review of service user care records; accident/incidents; restrictive practices; complaints; safeguarding matters; and staffing arrangements including recruitment and training.

Discussion with the person in charge and a review of records identified that incidents had been managed appropriately. RQIA had been notified of any incidents that are required to be reported in keeping with the regulations. No incidents had occurred that required investigation under the Serious Adverse Incidents (SAI) procedures.

The domiciliary care agency's provision for the welfare, care and protection of service users was reviewed. There was a procedure in place for staff to report concerns.

Discussions with the person in charge and staff established that they were knowledgeable in matters relating to adult safeguarding and the process for reporting and managing adult safeguarding concerns.

Staff had a good understanding of their responsibility in identifying and reporting any actual or suspected incidences of abuse and the process for reporting concerns. Staff could describe their role in relation to reporting poor practice.

The agency retained records of any referrals made to the Trust in relation to adult safeguarding. A review of records confirmed that these had been managed appropriately.

All staff had been provided with training in relation to medicines management; details of medications incidents are recorded

There was a system in place for managing instances where staff could not gain access to the individual homes of service users. This included a system whereby staff entered with the use of a master key; service users have consented to these arrangements.

The agency's registration certificate was up to date and displayed appropriately.

Checks were made to ensure that staff were appropriately registered with the Northern Ireland Social Care Council (NISCC) or any other relevant regulatory body. There was a system in place for professional registrations to be monitored by the manager on a monthly basis. A spot check completed during the inspection indicated that staff were appropriately registered. Staff spoken with confirmed that they were aware of their responsibilities to keep their registrations up to date.

Staff told us that they would have no issue in raising any concerns regarding service users' safety or care practices and that they were confident that the manager or person in charge would address their concerns.

Service users said they had no concerns regarding their safety; they described how they could speak to staff if they had any concerns about safety or the care being provided.

There was a system in place to ensure that complaints were managed in accordance with the agency's policy and procedure. There was evidence that where complaints had been received they had been managed appropriately. It was positive to note that a number of compliments had been received.

The Annual Quality Report was reviewed and was satisfactory; it included the views of service users and other key stakeholders. Comments included, "I feel very safe in my home, I am happy with the support provided."

Discussions with staff and review of service users' care records reflected the multi-disciplinary input and the collaborative working undertaken to ensure service users' health and social care needs were met within the agency. There was evidence that staff made referrals to the multi-disciplinary team and these interventions were proactive, timely and appropriate.

Staff had completed appropriate DoLS training appropriate to their job roles. The person in charge reported that a number of the service users were subject to DoLS. We discussed with the person in charge that where a service user was experiencing a deprivation of liberty, the care records needed to contain details of assessments completed and agreed outcomes developed in conjunction with the HSC Trust representative. An area for improvement was identified. Refer to Section 4.0 for more detail.
