

Since the launch of our previous website over nine years, there has been considerable change at RQIA.

At that time, we registered and inspected fewer than 700 services. However with the regulation of a range of services including day care, domiciliary care and private dental care, we now regulate around 1,500 services.

Our reviews programme has also developed significantly since this time and we have also undertaken the functions of the former Mental Health Commission and the Guidelines and Audit Implementation Network (GAIN).

In developing our new site we sought the views of service providers and the public through, asking for views on what you wanted from our new website.

The new site address the limitations of our previous site, with a clearer layout and navigation; guidance for both service providers and the public; an improved site-wide search function; map and listing options to make it easier to access inspection reports for the full range of adult services we inspect. The site is also responsive and adjusts to optimise the view on PCs, tablets and mobile phones.

From our home page you can access our latest news; details of enforcement action; guidance on complaints and whistleblowing; and information and guidelines from GAIN.




To ensure our website is fully accessible to those with sensory issues, dyslexia or low literacy, or English as a second language our website continues to be <u>browsealoud</u> enabled. This allows visitors to avail of speech, reading, and translation services in a wide range of languages.

Hospital Inspections



RQIA has published the findings of the first phase of its acute hospital inspection programme. Unannounced inspections took place at <u>Antrim</u>, <u>Royal Victoria</u>, <u>Ulster</u>, <u>Craigavon</u> and <u>Altnagelvin</u> hospitals. Reports for each hospitals are now available on our website, highlighting examples of good practice and areas for improvement. The second phase of inspections started earlier this month at Daisy Hill Hospital in Newry, and our findings will be available early in the new year.
